Colon Cancer Awareness Month

Month of March

The Cass County Health Clinic is encouraging colon cancer screenings through FIT Testing. The FIT test is a do-it-yourself 1-time test that is performed at home and can detect issues that would prompt a follow-up appointment with a provider.

Each year, more than 140,000 people are diagnosed with colon cancer, a highly preventable disease and it is the third most common cancer in the US. If everyone age 50+ got regular screenings, 6 out of 10 deaths could be prevented. Cass County is considered a high-risk county, so testing and early treatment are important to the health of our community.
